## MARITIME PROFESSION — Maritime Legal Services

Host: When I was a student
many of my friends wished to become lawyers
Perhaps influenced by TV dramas
they felt dealing with criminal cases was exciting
and lucrative
They had already pre-shaped themselves
But in fact how could the legal industry be so narrow?
If you want to go a bit wider and challenge yourself
why not try something special
and go for a different path?

Host: In Hong Kong, there are not many maritime lawyers and not many of them are from local
How did Devin find his way to become a maritime lawyer?
(Devin, Maritime Lawyer)

Host: Devin, why particularly is there a profession of lawyer in the maritime industry?

The other industries
e.g. the catering industry, does not specially have lawyers

What does a maritime lawyer do?

Devin: Maritime industry is one of the pillars for Hong Kong's economies

Maritime lawyers are professional lawyers
who support these economic activities

For example, a shipment from Hong Kong to Italy
will correlates with a lot of legal documents
such as the charter agreement and bill of lading

Maritime lawyers provide legal services exclusively for these documents

**Host**: Devin, as a barrister specialised in maritime disputes is your work different?

Devin: There are some differences

Where there is a maritime related business
possibly disputes may arise
A lawyer might be required to deal with these disputes
Barristers specialised in maritime disputes
are experts specialised in maritime related litigation
For example
Hong Kong International Arbitration Center
is an international arbitration center in the Asia Pacific region
One fifth of the cases are maritime related

**Host**: What are the differences between maritime cases and ordinary cases?

Can you tell me the cases you have dealt with?

**Devin**: Have you ever tried the king crab?

Host: Of course

Devin: I have dealt with one case related to the king crab
There was one client in Shanghai who bought
fifty tonnes of king crabs from Russia
There were twenty-five thousand king crabs in total

Host: Do not ask me the weight of each one

Devin: There was an accident during the transportation Some king crabs died, which caused a loss Here came the problem: Who should be responsible for the loss?
Should it be the buyer, the seller
the shipping company or the insurance company?
This is a very typical maritime arbitration case

**Host**: It is very challenging to be a maritime lawyer What qualifications are required if I want to join the industry?

Devin: If you want to be a maritime lawyer first of all, you have to be a lawyer In general, there are several ways While you are a trainee solicitor you can work in a maritime specialised law firm Afterwards, you can keep working to gain experience to become a maritime lawyer eventually Another way is to become an ordinary lawyer and further study the maritime law thereafter which can make you become a maritime lawyer

**Host**: Devin, how did you start?

Devin: I did not major in law either

My first degree is in Business Administration

Then I further studied the Master of Law

Afterwards I became a barrister

I hope to be more competitive after graduation

so I decided to be more specialised

I have the habit of reading the Policy Address

It enables me to understand

the Hong Kong Government's direction on future development

At the time, I knew the maritime services

would be further developed in Hong Kong

In addition, there was a maritime law scholarship scheme

So I applied

And I became a maritime lawyer

**Host**: It sounds that the threshold is still very high If I really do not have any law related qualifications in this field what other positions can I consider?

Devin: In fact, the scope of maritime legal services is quite broad Apart from being a lawyer many shipping companies and insurance companies will also recruit executive staff or clerks etc,.

You will also learn some laws, regulations and the other rules of the industry

Though you are not a lawyer it is considered as professional

Of course, if you want to be a maritime lawyer in the future you can further study law-related programme

**Host**: Are there many maritime lawyers in Hong Kong?

Devin: Compared with the United Kingdom
there are not as many maritime lawyers in Hong Kong
But along with the development of Hong Kong maritime services
I believe there will be more maritime lawyers
Hong Kong previously relied a bit much
on the maritime lawyers from the United Kingdom
Hong Kong could have more talents in this field
For now
we require talents who know both bi-literacy and tri-lingualism
and the Chinese culture
So, people who can have good proficiency
in both Chinese and English like us

are whom the market really thirsts after

**Host**: If I am really interested in the industry is there any way to find maritime law firms which recruit maritime lawyers?

Devin: Nowadays, the easiest way is to go online
I can give you two websites with relevant information
The first one is the Shipping Directory by the Marine Department
It lists the Hong Kong maritime law firms

Host: As long as you are determined, you will make it Although it is a long way to become a maritime lawyer if you have planned ahead set a clear target and move on step by step it will not take you long to achieve
